I. Call to Order

II. Board Operations

Non-practicing status does not allow for individuals to promote himself/herself as a Licensed Professional Counselor, Practice Counseling/Psychotherapy, provide Group or Individual Supervision, provide Distance Professional Services, or bill for Counseling/Psychotherapy. The Board will discuss procedural issues at the next meeting.
