# Mississippi State Board of Examiners for Licensed Professional Counselors

Regular Board Meeting Friday, May 21, 2021 Minutes

- A. <u>Office Closure Update</u> The Board decided that the Board's office will continue to be open by appointment only. The public can reach the Board's office by phone, email, and website. Ms. Mordecai conducts business in the office 2 days a week and, if needed, the public and licensees can schedule an appointment with her to facilitate in-person business.

Ms. Mordecai will post the information on the website and send email to all Mississippi licensees and all out of state licensees that notified the Board of their intent to provide telehealth services under the Board's March 16, 2020, Proclamation that all must comply with the Distance Professional Services Provider Rules and Regulations by September 30, 2021, in order to continue providing distance services.

- D. The Board will accept a PESI training from Joni Gilbertson for Telemental Health training from PESI because ACA partnered with PESI to provide Gilbertson's 12.5 CEH training. The Board has not reviewed nor approved any other PESI training for the purposed of fulfillment of the Rules and Regulations for Distance Professional Services.
- E. Ms. Mordecai is seeking an individual to fill the Administrative Assistant.
- F. Ms. Morris updated the Board regarding HB 1263, Universal Licensure Law. Dr. Sallis motioned, Mr. Boose seconded, to establish the following Emergency Rules and Regulations to comply with the Universal Recognition of Occupational Licenses Act (HB 1263) effective July 1, 2021 as follows:

Rule 4.8. Universal Licensing Requirements

This section is governed under the provisions of the Universal Recognition of Occupational Licenses Act found under Mississippi Code Annotated section 73-50-2. Please refer to this code section for information regarding qualifications for licensure under this Act.

Rule 4.9. Temporary Work Permit This section is governed under the provisions of the Universal Recognition of Occupational Licenses Act found under Mississippi Code Annotated section 73-52-9. Please refer to this code section for the qualifications for the temporary work permit.
