The Special Called Board Meeting for Strategic Planning of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:00 a.m. by Dr. Richard Strebeck, Chair ("Chair") on Thursday, September 9, 2021 at The Grand Hotel and Suites in Natchez, MS. A roll call of Board members was taken, and a quorum was present.

B. The Board reviewed the financial statements.

C. Due to technical issues occurring on the ITS Dell Hybrid Cloud server associated with WordPress, the Board received a proposal to move the existing WordPress site from the ITS windows server to a USNext Linux server. Mr. Stafford motioned, seconded by Dr. Etheridge, to accept the proposal from ProsonITech to move the existing WordPress site from ITS, initial set up with USNext and one year of hosting for \$600 and subsequent yearly hosting costs in the amount of \$480 per year and to add this to the financial policy as yearly pre-approved fees.

A. Board Requests

- 1. Board received requests from eleven (11) LPC requesting to change status to Retired. After review, the Board unanimously agreed to change status to these LPC to Retired.
- 2. (LPC #2413) submitted University of the Cumberlands unofficial transcript and syllabus for the Board to review for Distance Professional Services (DPS) provider status. After review, the Board agreed this coursework meets the requirements for DPS provider as set forth in the Rules and Regulations.
- 3. **Solution** submitted request to extend Candidate application past the current expiration date of 11/22/2021, which has already been extended 90 days from the original expiration date at its recent meeting. After review, the Board, upon unanimous vote, agreed to deny request to extend application deadline at this time.
- 4. **(#1468)** submitted request to reinstate 2017 lapsed license. After review, the Board unanimously agreed to deny request to reinstate lapsed license.
- 5. **CONTROL (LPC #0788)** submitted request to Voluntarily Surrender license due to relocation to another state where she is currently licensed. The Board reviewed and unanimously approved request to change status of #0788 to Voluntarily Surrendered.

- 6. **CENTRY (LPC #1076)** submitted various CEH training courses for the Board to review for Distance Professional Services (DPS) provider status. After review, the Board agreed to deny the submitted CEH because it does not fulfill the requirements for DPS provider as set forth in the Rules and Regulations.
- 7. **Submitted** submitted request for determination for review. After review, the Board unanimously agreed that based on the information she provided to the Board that the charges would not disqualify her from applying for licensure as a P-LPC or LPC.
- 8. **Solution** submitted request to extend maximum four-year as Candidate for testing again. After review, the Board unanimously agreed to deny the request for an application extension, she must apply for licensure with a new application because the current file will be destroyed. She must meet all of current licensure requirements.
- 9. (LPC #2655) submitted request to the Board regarding additional CEH she can add to the 30-hour supervisor training she has completed in the state of Louisiana. After review, the Board agreed should submit the supporting documents from the 30-hour CEH training course completed to determine if they can identify additional areas to needed to take 15 more hours of CEH or if she will need to complete a program that is 45 hours in its entirety.
