#### Rule and Regulations

- ► Telemental Health Rule 7.5
  - ► Complete telemental health training
    - Obtain the Board Certified Telemental Health credential
    - Graduate level class in telemental health as verified on transcript (and syllabus if needed)
    - Professional training course (continuing education) 9 CEH minimum
  - Upload certificate to online profile
  - ▶ Must be synchronous video. Asynchronous methods are not acceptable.
  - Must be licensed in MS and the state where the client is located

### Rule and Regulations Non-Practicing Status



- Non-practicing status definition (Rule 1.4.U)
  - Non-Practicing Status: Licensees may renew their license without completing continuing education. Non-practicing status does not allow for individuals to promote himself/herself as a Licensed Professional Counselor, practice Counseling/Psychotherapy, provide Group or Individual Supervision, provide Distance Professional Services, or bill for Counseling/Psychotherapy.
  - ► Fee: \$50 per year (Rule 2.1.0)

### Rule and Regulations Non-Practicing Status (Rule 5.4)



- A. Non-Practicing: An LPC who is not currently practicing in the counseling field and/or does not plan to return to the counseling field in the foreseeable future.
  - 1. Non-practicing licensees can retain the wall certificate.
  - 2. Licensees must apply for non-practicing status at the time of renewal.
  - 3. Non-practicing licensees are not required to complete annual CEHs to renew.
  - 4. In order to return to practicing Status, the licensee must pay the full licensing fee, complete the Jurisprudence Exam within the past 365 days, show evidence of 12 Continuing Education Hours within the prior 365 days, and complete background check (if requested by the Board).

  - ▶ Implement after 30 days.



#### Rule and Regulations - Revision Highlights Retired Status

Retired status is a permanent status - no option to return to licensed status

If you want to return to counseling, consider nonpracticing status.

The Board still requires 2 (two) tests for licensure

► P-LPC - Pass/Fail Jurisprudence Exam

- ► LPC ... 1 (one) national exam, EITHER
  - ► National Counselor Exam
  - National Clinical Mental Health Exam

The Board still requires 2 (two) tests for licensure

- ► P-LPC Pass/Fail Jurisprudence Exam
  - Accessed through your account using the Board's online portal
  - ▶ Based on ...
    - ► LPC Board's Rules and Regulations
    - MS Statutes governing counseling
    - ► ACA Code of Ethics

The Board still requires 2 (two) tests for licensure

- ► P-LPC Pass/Fail Jurisprudence Exam
  - ► Administered through NBCC/CCE, the Fee is paid to CCE
  - ▶35 questions
  - ▶ 1 hour time limit
  - ► Can retake in 30 days, if necessary
  - No CEH awarded

The Board still requires 2 (two) tests for licensure

- **LPC** 
  - At any time, you can take <u>either</u> of the following national exams without the Board's permission
    - National Counselor Exam
    - National Clinical Mental Health Exam

What about current P-LPCs and Candidates?

- "Any current P-LPC or Candidate who proceeds to apply for the LPC must submit verification of passing score report of the Pass/Fail Jurisprudence Examination."

Supervision settings

► LPC or an individual licensed to provide psychotherapy services independently in Mississippi is available on the premises.

### Rule and Regulations Revisions Outcomes

- Creates parity for licensees
- Streamlined licensure process
- Residents have greater access to counseling services
- ► Fewer complaints to the Board
