The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors (“Board”) was called to order at 9:00 a.m. by Dr. Kimberly Sallis, Chair (“Chair”) on Friday, June 26, 2023. The Board meeting was held at the Woolfolk Building, 501 North West Street, Room 139 North, Jackson, Mississippi 39201. A roll call of Board members was taken, and a quorum was present.

Upon motion at 10:06 a.m. made by Dr. Windham with a second by Mr. Boose, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a unanimous vote of 5-0.

In the determination session, Dr. Strebeck motioned, with a second by Dr. Etheridge, that the Board had reason to go into Executive Session [Mississippi Code Annotated §25-41-7 (b & d) and Mississippi Code Annotated §73-52-1 (1 & 2)]. The motion carried with a unanimous vote of 5-0.

Dr. Etheridge motioned, seconded by Mr. Boose, to reaffirm the Board’s January 20, 2023 denial for LPC Licensure. The motion carried with a unanimous vote of 5-0.

At 10:38 a.m. Dr. Etheridge motioned, with a second by Mr. Boose, to exit the Executive Session. The motion carried with a unanimous vote of 5-0. Upon returning to open session, the Board announced the aforementioned action.

**III. Administrative Hearing 2022-28**

As a preliminary matter, an Agreed Order was presented to the Board. The Board considered the Agreed Order in the complaint against Mr. Steven Stafford.

Upon the conclusion of testimonial and documentary evidence in the matter of #2022-28, the hearing concluded.

**V. Administrative Hearing 2022-28 (continued)**

The Chair reconvened Executive session at 9:00 a.m. The Board quorum consisted of Dr. Sallis, Dr. Windham, Dr. Strebeck, and Mr. Boose. Dr. Etheridge joined the meeting at 9:10 a.m.

Royce Cole, Hearing Officer, presiding.

Dr. Strebeck made the following motion, seconded by Dr. Windham, for adjudicating complaint #2022-28 for the following violations:

- American Counseling Association Code of Ethics:
  - A.1.b – Records and Documentation
  - A.11.d – Appropriate Transfer of Services
  - B.6.a – Creating and Maintaining Records

- C.1 – Knowledge and Compliance with Standards
  - LPC Board’s Rules and Regulations
    - Rule 3.2.J.2 – Engaging in the conduct of professional counseling in a grossly negligent or incompetent manner
1. The Licensee shall be suspended for a minimum of twelve (12) months from the date the Board Order is signed by the Board.
  2. Once the twelve (12) months suspension is completed, Licensee may request, in writing, that the Board issue him a Restricted Status LPC. The restricted status shall require the Licensee to practice counseling under supervision for a minimum of twelve (12) months. At the time of the request, the licensee shall submit a Request Letter, Declaration of Practice, and signed Supervision Agreement to the board.
    - a. The terms of supervision shall follow the guidelines set forth in Rule 4.3.b.
    - b. The LPC-S shall be approved by the investigator or his Board approved designee.
    - c. Once supervision is completed successfully, the LPC-S shall submit a Supervision Form B documenting the experience with recommendation regarding licensure.
  3. Licensee must maintain his LPC-S as pursuant to the rules and regulations of the Board.
  4. Respondent shall take 24 Continuing Education Hours (CEH) in Professional ethics, which shall include documentation and treatment planning, as approved in advanced by the Board investigator or her Board approved designee. These CEHs are in addition to the LPC renewal requirements. All CEH requirements must be NBCC approved and at least twelve (12) CEHs must be attended in person onsite. These Continuing Education Requirements are not included as part of the licensing renewal process.
  5. The Licensee shall be assessed the cost of the Board investigation and hearing costs.
  6. Once Licensee completes all the terms of this Board Order, he may request the Board to remove the Restrictions and return him to Active Status as an LPC-S.
  7. Licensee has 36 months from the signing of this Board Order to complete the terms and conditions herein.
  8. Licensee is aware that if he violates the terms of this Agreed Order or further violates the laws, rules, regulations, and code of ethics governing practice as a licensed professional counselor, the Board may take further disciplinary action against Respondent, up to and including suspension and revocation of her license.

Dr. Windham motioned, seconded by Dr. Sallis, to amend Dr. Strebeck’s motion by changing item #1 as follows:

The Licensee shall be suspended for six (6) months from the date the Board Order is signed by the Board. The motion carried and the vote was as follows:

At 10:25 a.m., Dr. Etheridge motioned, seconded by Dr. Strebeck, to exit Executive Session and return to open session. The motioned passed with a unanimous vote of 5-0.

Upon returning to open session, the Board reported the findings and adjudication for complaint #2022-28. The Final Order will be attached to these minutes when it is signed by the Board Chair.

## **VI. Board Operations**

### **A. May 5, 2023 Minutes**

After reviewing and making corrections to the May 5, 2023 minutes, Dr. Windham motioned, Mr. Boose seconded, to approve the minutes as amended. The motioned passed with a vote of 4-0-1. Dr. Strebeck was not present for the vote.

### **CLOSED DETERMINATION/EXECUTIVE SESSION**

Upon motion at 11:30 a.m. made by Dr. Windham with a second by Mr. Boose, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a unanimous vote of 5-0.

In the determination session, Dr. Strebeck motioned, with a second by Dr. Etheridge, that the Board had reason to go into Executive Session [Mississippi Code Annotated §25-41-7 (b & d) and Mississippi Code Annotated §73-52-1 (1 & 2)]. The motion carried with a unanimous vote of 5-0.

Dr. Strebeck motioned, seconded by Mr. Boose, to exit Executive Session at 11:42 a.m.

Mr. Boose motioned, Dr. Strebeck seconded, that the Executive Director receive a 3% salary increase (\$2,164.24) beginning July 1, 2023. The motion carried with a unanimous vote of 5-0.

In open session, the Board reported out the above action taken during Executive Session.

## **VII. Financial Matters**

- A. Dr. Etheridge motioned, Dr. Windham seconded, to approve the travel for the meeting. The motion carried with a vote of 4-0-1. Dr. Strebeck was not present for the vote.
- B. Dr. Windham motioned, Mr. Boose seconded, to pay the yearly membership for the American Association of State Counseling Boards. The motion carried with a vote of 4-0-1. Dr. Strebeck was not present for the vote.
- C. The Board reviewed the proposed contract with Cornerstone Consulting, Inc. for accounting services for FY24. Dr. Windham motioned, Dr. Sallis seconded, to approve the FY24 contract for financial services with Cornerstone Consulting, Inc. The motion carried with a vote of 4-0-1. Dr. Strebeck was not present for the vote.
- D. The Board reviewed the travel reimbursement for Board members. Based on a prior Attorney General Opinion, the Board discussed that travel reimbursements are subject to the State of Mississippi employee rates.
- E. The Board reviewed the Financial Report for June 2023.
- F. The Board reviewed the FY24 Budget with no changes.

- G. The Board discussed attending the NBCC Counseling Summit Regulatory Board conference in Nashville, TN on July 26-28. Dr. Strebeck motioned, seconded by Dr. Etheridge, for the Board to pay travel expenses not covered by NBCC for Board members and the Executive Director.

### **VIII. Old Business**

- A. The Board discussed topics for the Strategic Planning meeting for September 2023. Topics include impaired professionals, complaint process, budgeting, Pass/Fail Jurisprudence Exam review, and increased communication.
- B. The Board will present at the Mississippi Counseling Association in November 2023 in Biloxi.

### **IX. New Business**

- A. Dr. Sallis announced that Governor Reeves appointed Dr. Lewis Anthony Bullock for District IV representative replacing Mr. Boose and Dr. Kerri McKnatt for District II representative replacing Dr. Etheridge.
