II. <u>Board Operations</u>

- A. The Board reviewed the minutes for April 9-10, 2024. Dr. Strebeck motioned, seconded by Dr. Sallis, to approve the minutes as submitted. The motion carried with a vote of 3-0.
- B. The Board reviewed the minutes for April 9-10, 2024. Dr. Sallis motioned, seconded by Dr. Strebeck, to approve the minutes as submitted. The motion carried with a vote of 3-0.
- C. The Board reviewed the May 2024 financial report.
- D. The Board reviewed the appropriations request from the legislature for FY 2025.
- E. The Board confirmed that the CE Broker contract was signed and will be implemented.
- F. Dr. Windham motioned, seconded by Dr. Strebeck, to approve the Cornerstone Consulting, Inc. contract for accounting services. The motion carried with a vote of 3-0.

- C. Dr. Strebeck motioned, seconded by Dr. Sallis, to grant Michelle Kim's request for a Denial of Licensure hearing.
- D. Dr. Strebeck motioned, seconded by Dr. Windham, to deny Lula Nichols request. The motion carried with a vote of 3-0.
- E. Dr. Sallis motioned, seconded by Dr. Strebeck, to grant LaKeida Ward a 6-month extension to complete licensure requirements. The motion carried with a vote of 3-0.

Upon the conclusion of business of Executive Session, Dr. Windham motioned, seconded by Dr. Strebeck, to exit Executive Session. The motion carried. The motion carried with a vote of 3-0.
