#### II. Strategic Planning

- C. Dr. Windham motioned, seconded by Dr. Strebeck, to nominate Dr. Sallis as the alternate delegate for the Counseling Compact. The motion passed with a vote of 5-0.

- F. Dr. Sallis motioned, seconded by Dr. Bradley, to add the following to Rule 7.5.3.C:

The LPC-S is responsible for verifying the onsite licensed practitioner, as referenced in Rule 4.2.E.6.

The revised rule is as follows: P-LPCs can practice TeleMental Health counseling with the approval from his/her/their LPC-S, who must be designated by the Board to be a Distance Professional Services provider. The LPC-S is responsible for verifying the onsite licensed practitioner, as referenced in Rule 4.2.E.6

The motion passed with a vote of 5-0.

Upon motion made by Dr. Strebeck, seconded by Dr. Windham, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a vote of 5-0.
